

**TERMS AND CONDITIONS FOR THE UCOUNT REWARDS FOR BUSINESS AND
MERCHANT SERVICES PROMOTIONAL OFFER MADE BY THE STANDARD BANK OF
SOUTH AFRICA LIMITED (STANDARD BANK/US/WE/OUR)**
