**TERMS AND CONDITIONS (TERMS) FOR THE UCOUNT REWARDS BUSINESS VISA**  
**CREDIT CARD ACQUISITION PROMOTIONAL OFFER**

*Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may exclude or limit our liability (responsibility) to you.*

**1. INTRODUCTION**

- 1.1 We are offering you the opportunity to collect 2500 UCount Rewards points when you successfully apply for a Standard Bank Business Visa credit card (**Card**) (**Offer**).
- 1.2 The Offer starts at 00:00 on Friday, 16 April 2021 and ends at 23:59 on Monday, 31 May 2021 (**Offer Period**).

**2. WHO QUALIFIES FOR THE OFFER**

- 2.2 permanently reside in the Republic of South Africa.
