TERMS AND CONDITIONS (TERMS) FOR THE “UCOUNT POINTS” PROMOTIONAL OFFER
(SOLE PROPRIETORS)**

Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.

1. INTRODUCTION

1.1 We are offering you the opportunity to collect up to 3000 (three thousand) UCount Rewards for Business points when you either:

1.1.1 take up a VISA corporate credit card with Standard Bank and register for UCount Rewards for Business (**Card**); or
